

**AdaMagic® Ada to Commented C/C++ conversion tool  
License Agreement  
("Agreement")**

This Agreement governs the use of SofCheck AdaMagic Ada to Commented C/C++ conversion tool between SofCheck, Inc., 11 Cypress Drive, Burlington, MA, 01803 U.S.A. ("Company"), and \_\_\_\_\_, of \_\_\_\_\_ ("Licensee") and is dated \_\_\_\_\_, 200\_.

This license agreement governs AdaMagic® Ada to Commented C/C++ conversion tool ("Software"). By signing this Agreement and / or installing or using the Software the Licensee enters into the terms of this binding contract between itself ("Licensee") and SofCheck, Inc. If the Licensee does not agree with the terms of this license, it shall uninstall and not use the Software. Installation or use of the Software constitutes acceptance of the terms of this License Agreement.

**Grant of License:** Subject to the terms and conditions of this Agreement and specific purchase limitations as specified in Appendix A of this agreement, SofCheck hereby grants the Licensee a limited, nonexclusive license to install and use the object code version of the Software.

**Limitations:** The Software is licensed, not sold, to the Licensee. The Licensee must retain all copyright and related notices of SofCheck's ownership and other rights in the Software in the product, labeling and documentation provided. Furthermore, the Licensee may not: (a) modify, translate, de-compile, reverse engineer, disassemble or otherwise decode the Software; (b) make copies any of the Software other than as reasonably required for use of the Software in accordance with this Agreement; or (c) sublicense, sell, rent, lend, transfer, post, transmit, distribute or otherwise make the Software available to anyone else.

**Trademarks:** The Licensee acknowledges that SofCheck, AdaMagic and related logos and designs are trademarks of SofCheck, Inc. and that no rights in such trademarks are granted to the Licensee by this Agreement.

**Support:** Unless otherwise provided for in a separate Maintenance Agreement, SofCheck reserves the right to modify the Software from time to time without obligation to notify the Licensee or any other person or organization of such revision or change. SofCheck shall provide a limited number of hours of telephone or email support as specified in Appendix A. of this Agreement. Support beyond that number of hours shall be billable and contracted for separately.

**Limitation of Liability:** IN NO EVENT WILL SOFCHECK BE LIABLE FOR ANY DAMAGES, INCLUDING LOSS OF DATA, LOST OPPORTUNITY OR PROFITS, COST OF COVER OR ANY SPECIAL, INCIDENTAL, CONSEQUENTIAL, DIRECT OR INDIRECT DAMAGES ARISING FROM OR RELATING TO THE USE OF THE SOFTWARE, HOWEVER CAUSED ON ANY THEORY OF LIABILITY. ### AdaMagic® Ada to Commented C/C++ conversion tool Product Pricing Covered by this Agreement

The pricing is per project or system converted and based on a cumulative count of Lines of Ada Source Code Converted "LOCC" (\*1.) measurement and assumes installation on a single server, for a limited project conversion period of 6 months (\*2). The products are available off the shelf for Windows and Solaris (and by special order for Linux and MAC)

(\*1.) SofCheck will count the Ada lines of source code during conversion and will ignore comment and blank lines in the count. If the cumulative actual LOCC count exceeds licensed count the tool will stop and warn user of licensing issue and ask them to contact SofCheck. If a count is desired prior to contracting for the tool SofCheck can do a count as part of the purchasing process.

(\*2.) If the 6 month time duration is exceeded the tool will notify the user in advance that their key has expired and ask them to contact SofCheck. If the project requires additional time to complete its conversion, upon written request SofCheck will extend the conversion period as needed.

(\*3.) SofCheck shall include the listed number of hours of telephone and/or email product support with each level of license. Support hours shall be counted in minimum ½ hour increments and rounded up to the next ½ hrs of actual time expended. Additional support may be purchase in blocks of 5 hrs at a rate of \$1,000 per 5 hr block.
